

LETTER FROM THE DIRECTOR

am proud to write this letter after a remarkable year of expansion, during which Plan A grew our services and team to meet the evolving needs of our community.

Plan A's work is guided by the needs and priorities of the people we serve. Our team engages every day in thoughtful conversations with our patients and community about how we can advance our mission and expand access to healthcare in the Mississippi Delta. In 2022 we continued working to meet the ever-growing needs of the people we serve — without compromising our sustainability and core commitment to our mission.

For example, we knew from our conversations with patients that many people were unable to obtain emergency contraception (EC). That led to the successful launch of our "Plan A's Plan B Care Packages" program in July 2022, which mails EC, condoms, and pregnancy tests throughout the state. As we began offering the prescription-only version of EC via telehealth visits, patients began requesting birth control as well.

In November, we expanded our telehealth offerings to include all forms of family planning, with free prescriptions mailed out weekly from our pharmacy. The mobile unit continues to play an essential role in increasing access to care to our communities, but it can't reach everyone. Expanding our telehealth program has allowed us to grow our footprint substantially.

We also recognize that part of our role as a reproductive justice organization is to support healthy pregnancies and deliveries. Through partnerships with OB-GYNs and our purchase this year of portable ultrasounds, our clinics can provide critical pre- and postnatal services, reducing the time required to travel for care.

It is impossible to reflect on 2022 without acknowledging the devastating impact of politics and the eradication of access to abortion. The Mississippi Delta is a reproductive and maternal healthcare desert.

One of the few labor and delivery floors in the region closed this year, and several OB-GYNs left the area, eliminating services from three of the counties in which we operate. These widening gaps only worsen the outlook in a state that already has one of the highest rates of maternal and infant mortality in the United States.

Mississippi's continued failure to expand Medicaid leaves up to 40% of the communities we serve uninsured, a gap with immeasurable and far reaching impact on the health of the entire population. Residents of the state have the lowest life expectancy at birth in the country. At our brick-and-mortar clinic and pharmacy in Louise, we are able to address critical primary care needs. Services in Louise also experienced significant growth, with the addition of dental and pediatric care. In 2023, we will add additional specialty services in partnership with local providers.

Our work providing essential reproductive health services is more important than ever. It is a model that has already had substantial impact in the counties we serve and, critically, has the potential to scale. Last year, we began the process of working toward our second mobile unit, which will open in rural Georgia in 2023. We also engage in regular conversations with other clinics nation wide, supporting and encouraging their efforts to launch mobile units or add reproductive health services to existing ones. Our work is all made possible by the generosity of our donors, whose support totaled more than \$2 million in 2022.

We look forward to a busy and productive 2023 as we seek to advance our mission and ensure that all communities have access to the reproductive health services they deserve.

THE ROAD AHEAD

ur 2022 saw the Mississippi program grow in extraordinary ways. It was Plan A's first full year on the road and we more than doubled our patients seen in 2021.

We added a whole range of new services and programs, all designed and launched in careful partnership with our communities. Our growth continues in 2023 and beyond

Georgia Clinic: Our next mobile unit will open in rural Georgia in 2023. Rather than simply replicate our Mississippi program, we will take the same deliberate approach, building a customized program from the ground up to meet the needs and priorities of the new community we will serve.

Expanding in Mississippi We will continue our work adding additional services in the Delta, including expanding our obsterics services and partnerships with specialists to bring a new range of care to our communities. We hope to serve an additional 500 patients in 2023.

A model clinic: Plan A is the lead clinic on a multi site study, forming a coalition with other mobile sexual and reproductive helath clinics in the country to look at the impact of this model on access to care. Together, we are developing a guide to building new clinics and adding reproductive health services to existing ones. This collaborative effort will expand our impact as an organization beyond the communities we serve directly to benefit people throughout the country.

FINANCIALS

Il of Plan A's services are provided to our community free of charge, regardless of insurance status or ability to pay. That is possible due to the generosity of our supporters.

In 2022, we received more than \$2 million in donations. That does not include an additional \$300,000 in grants due to be distributed in 2023. For every dollar donated, 86 cents was spent on program expenses, 10 cents on administrative expenses, and 4 cents on fundraising.
